14 Community Governance Review (CGR)

Wiltshire Council has advised that it intends to carry out a wider CGR including all Parishes into the impact of a new parish for Derry Hill and Studley should one be formed and any other changes in the area that are requested. It has asked that Council prepare their thoughts on this at a meeting as soon as possible after the May 2021 election. This Council also has the opportunity now to make any update to its previous response.
