Calne Without Parish Council 8<sup>th</sup> March 2021 Agenda Item 11 Calne Community Area Transport Group (CATG)

#### Introduction

Calne CATG met on the 18<sup>th</sup> February 2021 a summary of the updates for each live issue is in the table at Appendix 1. The following identifies all the issues returned to the Parish Council for consideration.

## Issue 6890 Parking Congestion at Church Road, Derry Hill

The experimental traffic order which put in place the waiting restrictions in Church Road, Derry Hill in August 2020 outside the school in an effort to reduce congestion and improve road safety has now come to the end of its consultation period. The Council is asked to decide if it wishes the scheme to be made permanent.

Wiltshire Council has not received any objections to the scheme. The Highways officers are content that although the school has not been fully operational during the entire period that it has had sufficient trial. The Council has the option to confirm the scheme as it stands or to request that some restrictions be removed but cannot add further restrictions.

# Issue 3-20-7 Studley, Studley Lane – request to deter parking at junction of Studley Gardens

The Highways officer has visited the site and considered the problem and the options available including that suggested by Cllr Rees to extend the junction out into Studley Lane. CATG has suggested that a solution of double yellow lines on both sides of the road from the junction of the A4 to the Sawmill car park to be taken back to the Parish Council for comments.

### **Cherhill Jugglers Lane and National Cycle Route linking Calne and Avebury.**

The 403 Sustrans Cycle Route to the east of Calne which goes to Avebury was identified by Wiltshire Council as part of the Covid response as a cycle route that could be improved. The scheme did not become part of the list approved to go forward by Wiltshire Council, but these schemes were referred to the local CATG to see if the group wish to support them. Cherhill Parish Council has asked for various improvements to be considered on its part of the route and Calne Without has been asked to look at its section and in particular the signage.

The Parish Council is asked to look at its part of this right of way/ cycle path and propose improvements to the path and signage of required as part of a wider project with Cherhill PC, Highways officers have asked that the Council consider the information necessary for users that have no knowledge of the local area.

#### Recommendations

1. That the Council request that Wiltshire Council take the necessary steps to confirm the traffic order for Church Road, Derry Hill without alteration thereby making permanent the waiting restrictions and the improvement to road safety.

- 2. That the Council consider the possible introduction of double yellow lines on both sides of Studley Lane from its junction with the A4 to the Sawmills car park.
- 3. That the Council ask the Footpaths Working Group to look at the signage for the Sustrans route 403 easy of Calne and come back to the May meeting with recommendations to be taken back to CATG
