Calne Without Parish Council Budget and Precept Request for 2024/25

1 Introduction

1.1 Budgets and precepts in the previous five years have been:

2019/20	£24,000	£17.97

- 1.2 The deadline for parish councils to confirm their precept requirement for 2024/25, to Wiltshire Council, is 18th January 2024.
- 1.3 Wiltshire Council have recently completed a consultation on changes to their Council tax reduction scheme. The outcome of this consultation will be confirmed on Tuesday 12th December 2023. CWPC have been provided with two tax base calculations, based on both the existing and proposed Council tax reduction scheme. has confirmed the tax base for 2024/25 as £1514.08 (if no changes are made to the scheme) or £1507.96 (if changes are made to the scheme.)
- 1.4 The Draft Budget for 2024/25 was developed by the Finance Committee and presented to the Parish Council for review on 9th October 2023.
- 1.5 The Council Meeting of 9th October provided direction that the council was keen to not increase the precept rate per Band D property.

Note: minor amendments have been made to the Draft Budget presented on 9th October 2023, as follows:

- YTD costs updated to 5th Dec.
- Current payroll costs updated.
- Bin Emptying increase to allow for all bins to be serviced at the new rate quoted for the new bin at lower Compton.
- Inflation costs of 5% added to most budget lines.
- Minor amendments made to IT lines following review of licenses.
- Public participation budget increased to include Remembrance day closure and extra work to publicise CGR changes and elections.

3 Precept Calculation

- 3.1 The finance committee note that the Full Council are keen not to increase the precept request per household. The finance committee are therefore proposing requesting a precept at a level that results in a band d precept of £21.72. The difference between the running cost budget and precept request to be funded from the income received from interest from saving account.
- 3.2 For the proposed Running Costs Budget of £36683.23, the resultant precept calculations are as follows:
