- 1. The County of Wiltshire (A4 New Road, Studley, Calne Without) (50mph Speed Limit) Order 2019 is hereby revoked.
- 2. No person shall drive any vehicle at a speed exceeding 40 miles per hour on the lengths of road specified in the Schedule to this Order.
- No speed limit imposed by this Order applies to vehicles falling within Regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those Regulations.
- 4. This Order shall come into operation on xxxxxxx 2023 and may be cited as The County of Wiltshire (A4 New Road, Studley, Calne Without) (40mph Speed Limit) Order 2023.



Statement of Wiltshire Council's reasons for proposing to make the Orders

RTRA 1984 SECTION 1 (1)

- (a) For avoiding danger to persons or other traffic using the road or any other road or for preventing the likelihood of any such danger arising;
- (b) For facilitating the passage on the road or any other road of any class of traffic (including pedestrians).

These proposals are being taken forward on behalf of Calne Without Parish Council and Calne Local Highway and Footpath Improvement Group as a result of concerns in the local community. An assessment has been undertaken in line with Wiltshire Council adopted policy on the siting of local speed limits and found that the locations proposed meet the criteria for the introduction of 40mph and 50mph speed limits.

NOTICE IS HEREBY GIVEN THAT Wiltshire Council proposes to make the above Orders under the Road Traffic Regulation Act 1984 the effect of which will be as follows:

Order 1

To revoke The County of Wiltshire (A4 New Road, Studley, Calne Without) (50mph Speed Limit) Order 2019 and to introduce a 40mph speed limit on the following length of road:

A4 New Road, Studley, Calne Without – from a point 273 metres west of its junction with Studley Lane (north side) to a point 193 metres east of that junction

Order 2

To introduce a 50mph speed limit on the following length of road: A4 New Road, Studley, Calne Without – from a point 193 metres east of its junction with Studley Lane (north side) to a point 19 metres west of its junction with Norley Lane
