The Council of the County of Wiltshire in exercise of its powers under Section 3 of the Cycle Tracks Act 1984 and having undertaken the consultations required by Regulation 3 of the Cycle Tracks Regulations 1984, hereby makes the following Order: -

- 1. The County of Wiltshire (Footpath 65, Calne Without) (Cycle Tracks) Order 2018 is hereby revoked.
- 2. The footpaths described in the Schedule to this Order are hereby designated as cycle tracks.
- 3. This Order may be cited as The County of Wiltshire (Footpath 65, Calne Without) (Cycle Tracks) Order 2024 and shall come into operation at the end of 28 days from the date on which notice of confirmation of this Order is first published.



NOTICE IS HEREBY GIVEN THAT Wiltshire Council has made the above Order, which requires confirmation, under the Cycle Tracks Act 1984 the effect of which will be as follows:

To revoke The County of Wiltshire (Footpath 65, Calne Without) (Cycle Tracks) Order 2018, re-enact it in the above Order and to designate the following length of footpath as a cycle track:- Footpath 65, Calne Without – from a point 90 metres south of its junction with A4 for a distance of 9 metres in a southerly direction
