Got to have something in place to start with, need to have plans in place, and make sure that it's a three year plan to give time to establish plans and funding.

Will we be able to fund projects that have moved over from CWPC,

It was noted that it's a tricky situation we are in if projects slip we will need precept to cover these projects, will we know if projects have slipped? Will we know if projects need funding from precept? What will precept cover need to be to cover project slips.

The committee resolved to progress with a new adapted strategic plan with Cllr Barnes to be the editor of the new plan with support from Cllr Todd.
