Highway Improvement Request Form Pewsham House – Request for Parking Restrictions

1. Introduction

In October, the Council received a Highway Improvement Request Form from a resident of Pewsham House. The resident reports that, at different times of the day, there are numerous people parking at the end of their driveway, and that, on one occasion, this had prevented a delivery.

The resident requested that double yellow lines be added on both sides of the end of the roadway next to their entrance, and extending back approximately 25m.

A copy of the Form is provided as Appendix A.

2. Background and Discussion

Pewsham House is a late Victorian Country House. There are ten addresses there: as well as the main house, there are six flats in the house itself, as well as three mews properties in the old stable block.

The driveway to Pewsham House is at the bottom end of the old section of Old Derry Hill, which is a dead-end, left as public highway for access to properties after it was bypassed when the A4/A342 junction was remodelled.



This section of the old road is frequently used for on-street parking by visitors, both for dog-walking and, reportedly, as over-spill parking to the public house.



The turn into the entrance is quite sharp and it is certainly possible that inconsiderate parking could potentially block access for delivery lorries and/or emergency vehicles.

The issue has been discussed with Wiltshire Council. Although it would be unlikely for double yellow lines to be installed to protect a residential entrance, an alternative would be the installation of an Access Protection Marking:



These are advisory, so not enforceable, but could potentially have an effect as there is generally plenty of alternative space along the old road.

However, this section of the road is tree-lined and the road gutters have a tendency to get filled up with detritus. It is therefore likely that any lining installed would get rapidly obscured and would therefore be ineffective.

An alternative would be for the owner of Pewsham House to put up some polite notices on the gate asking visitors to keep the access turning free for emergency vehicles.

3. Recommendation

The Highway Improvement Request Form has been considered by the Council's Highways, Transport and Road Safety Working Group, with the recommendation that:

• Whilst acknowledging the issue, the Council does not consider that a lining solution would be effective and recommends that the problem should continue to be monitored and that the owner installs some polite notices on the entrance asking visitors to keep the access free for emergency vehicles.
