The councillors discussed the previous concerns raised and the response to those concerns in this updated application.

It was noted that there is still an issue with screening, glare and glint.

The clauses in the community fund agreement are a concern.

Proposal;

Calne Without Parish Council would like to submit a qualified objection to the application, due to our concerns detailed below. If these concerns were to be properly addressed, we would support the application as it would be a good use of a redundant landfill site and would make use of existing grid connections."

- 1. The Pre-Planning Consultation has been poorly executed this is a statement of fact. No further consultation has been undertaken despite the council's offer to discuss these issues with the applicant.
- 2. Construction access route. Whilst this has now been clarified, serious disruption is being caused along the access road by Viridor contractors starting to import material to put on top of the site. No provision was made to clean the wheels of the HGV's causing mud to be spread all over the highway creating a dangerous road surface this is contravention of the referendum version of Calne Community Neighbourhood Plan 2 (CCNP2) policy GA1.

See notice from Hills regarding the mud on the road below:

"Statement – Mud on Sandpits Road

Following reports attributing mud along Sandpits Road to Hills' vehicles, we can confirm that Hills is not responsible. Valencia Waste Management is undertaking works on their restored landfill site (formerly operated by Viridor), on land adjacent to Hills' Sands Farm operations, and have vehicular right of way through our land to access their site.

The vehicles accessing the Valencia site are responsible for the current excessive mud on the public highway up to the Bug and Spider roundabout. Hills has repeatedly made Valencia aware of the problem and requested they put measures in place to resolve this matter.

We have been in touch with Wiltshire Council Planning Department, who have visited the site and confirmed that vehicles attending the site are the source of the mud.

We have also relayed the issue to the Environment Agency whose remit it is to regulate against the site permit. We understand that they are aiming to visit the Valencia site sometime this week."

Communications Department, Hills. 21st January 2025

The Construction Transport Environmental Management Plan contains no proposals about controlling mud from vehicle movements and request a condition that the applicant provides a wheel wash to clean the wheels of vehicles and regular use of a road brush, as necessary, to keep the adjacent road network clean.

- 3. Community Fund. A community fund proposal has been made. Whilst it is at the low end of what is usual for such solar farms an enhanced contribution should be made to reflect the overbearing impact that the site will have on many houses in Lower Compton and beyond.
- a. Issues with break clauses 7.1 is a break clause which the Parish Council has no influence or control on; 7.2 holds provisions to terminate on failure to meet the requirements of clause 4.6, which is harsh, without any process of prior escalation (such as serving notice).
- b. The draft agreement doesn't appear to index link the payment. It defines what "Index Linked" means but it doesn't say that the annual payment will be index linked.
- c. I think we should ask that Wiltshire Council benchmark the value of the fund against similar projects (although I think it is comparable to Forest Gate).
- d. Note that it will need to be between the applicant and Cherhill Parish Council.
- 4. National Cyle Route 403 and permissive paths.

- a. No new proposals were made in this area. CCNP2 policy GA6 seeks to promote the extension of route 403.
- b. The council supports Wiltshire Council Rights of Way comment "National Cycle Way 403 runs to the North of the site. This route currently uses 1,240 meters of road to get to the junction of Marsh Lane. This could be cut to 560 meters of road walking/cycling to get to the Marsh Lane junction. I would make the request that a cycleway is conditioned which joins from Low lane and extends to the land ownership

boundary north of Trenchard Avenue. If you look at the map supplied by the applicant titled site location plan the current route of the cycleway is shown by green dots and green circles. If this is not acceptable then I would request a section 106 contribution towards surface upgrades and improvements on Cycleway 403. I would suggest a contribution of £1,000 per year for the life of the development to be paid prior to connection to the electricity grid. If the solar farm was to be granted an extension in timespan in the future then the figure of £1,000 per year should be index linked from 2024 to the date of the extension of permission."

- c. the current S106 undertaking to restore the landfill site includes a permissive path within the restored landscape. This doesn't appear on the indicative solar farm layout.
- 5. Foundation proposals. Sufficient information has been provided.
- 6. Glare & Glint.
- a. Housing 34 of the 50 assessed dwelling receptors show that glare is geometrically possible. The planning application assesses that this will be mitigated by existing screening vegetation. Most of this screening is deciduous in nature and not on land owned by the applicant. See photo below showing the site from ground level. The site would be even more visible from first floor windows. Glare from winter / spring sun could easily impact the dwellings and there is a possibility that the owners of the land could remove the screening vegetation at some point in the future. As it is not in a conservation area planning permission would not be required to do this. NPPF(2024) states in para 135f that developments should "create places that are safe, inclusive and accessible and which promote health and well-being, with a high standard of amenity for existing and future users". The potential for glare into many properties does not provide a high standard of amenity and does not promote health and well-being. CCNP2 policy BE1 mandates that developments must be appropriate in scale and size and not dominate the surrounding area. NPPF (2024) paragraph 135b says that developments should have appropriate and effective landscaping.
- b. The landform that is being built up under the existing planning consent 15/10219/WCM has steep gradients on the east and south-east boundaries of the site, which is likely to limit the effectiveness of the screening being provided.

- c. The landscape and visual impact study doesn't include any visualisations from different viewpoints, which we would expect to see in an application such as this.
- 7. Visibility from the North Wessex Downs National Landscape and glare into it. CCNP2 policy NE5 seeks to protect important views, such as the one from the National Landscape to St Mary's Church in Calne. This development will cause glare from the proposed solar farm into the National Landscape severely impacting this view. The NPPF (2024) states in para 189 "Great weight should be given to conserving and enhancing landscape and scenic beauty in National Parks, the Broads and National Landscapes which have the highest status of protection in relation to these issues."

It was unanimously resolved to approve a qualified objection response based on the reasons above.

517.2/25 pre application consultation – Land East of Spitfire Road 20 Houses. To consider the <u>pre application consultation</u> from Robert Hitchins homes and develop a response.

The following response was proposed;

The proposed development is not among the sites identified by Wiltshire Council in the emerging Local Plan and is therefore not supported. Calne lacks the infrastructure to support an increase in housing, and the inevitable rise in traffic will negatively impact the Air Quality Management Area (AQMA).

Should the developer proceed due to Wiltshire's lack of a 5-year housing land supply, despite the area not being allocated in the draft Local Plan, any forthcoming planning application is expected to adhere strictly to the referendum version of the Calne Community Neighbourhood Plan 2 and the Calne Community Neighbourhood Plan Design Guidelines and Codes (Design Guide). Considering the referendum is scheduled for February 27th, 2025, it is anticipated that these documents will be formally adopted ("made") by the time any planning application is submitted. The application should also comply with the National Planning Policy Framework (NPPF) 2024, which places significant weight on local design guidelines and codes, particularly paragraphs 129, 130, and sections 12 and 15.

Specific attention should be given to:

- · Mitigating the flooding risk in the area, as several "once in a hundred years" flooding events have occurred there in recent years, possibly due to climate change.
- · Ensuring a suitable road crossing is constructed. Spitfire/Gregor Road experiences heavy traffic, making it difficult to cross during peak times. This issue is further compounded by the need for young families to cross the road to reach schools during these periods.
- · Ensuring the layout of the development and the design of the houses meet or exceed the criteria documented in the Design Guide.

In addition it was proposed that the council enquire about the range of affordable housing proposed and if he developer intends to put forward any other sites in the locality over the next 5 years.

AON responded; these things are very complicated, the whole appeal, is that WC getting bombarded with appeals, after the changes to NPPF and the new housing targets, problems with opposing at appeal is have to spend a lot of money and if loose costs go towards the council of the applicant. Minefield of lots of issues.

Cllr 0 Neill (Wiltshire Council) stated that he will be calling this in as it is not an allocated site.

It was unanimously resolved to provide a response based on the proposal above.

518/25. Update from Neighbourhood Plan,

To receive a verbal update from the progress of the neighbourhood plan. Cllr Barnes provided a summary. The Referendum is being held on 27th February. We are now in the pre-election period; we cant promote how to vote but can promote need to vote.

We held a briefing meeting with successor councils earlier in January went through arrangement on how to use neighbourhood plan after the referendum. Talked about how to capture and record successes and creating a joint list of projects and moving to early review of plan once Wiltshire local plan made, talked about the process for a new review.

Cllr Robbins- Noted the independent examiners comments that this excellent example of a review.

Cllr Barnes specifically discussed items 7,8, 9 and 10 on the report, for information all other items are detailed in following items.

519.2/25 A4 Studley Crossroads Speed Limit Reduction – approval of increase to Parish Contribution

To authorise payment of the Parish Council's contribution towards the completed speed limit reduction scheme on the A4 at Studley Crossroads, which requires an increase in authorisation from £3,750 to £3,821.31, representing 30% of the final cost.

Recommendation: that the Council approves payment of £3,821.31 towards the completed scheme.

Budget: Road Safety Budget (to be funded from CIL Reserve).

Power: Road Traffic Regulations Act 1984 S72

It was unanimously resolved to approve the increased contribution to £3821.31.

519.3/25 A4 Studley Crossroads Speed Survey

To consider further action following implementation of the new speed limit on the A4 at Studley Crossroads.

Recommendation: that the Council requests that Wiltshire Council conduct a speed survey on the new 40mph section to provide quantitative evidence of non-compliance with the revised speed limit.

It was unanimously resolved to request the proposed speed survey.

519.4/25 Studley 20mph Speed Limit Consultation

Recommendation: that the Council reconfirms its support for the new speed limit in the consultation, given the residential nature of settlement, lack of footways and streetlighting, reports of accidents and near-misses involving pedestrians and representations received from residents

It was resolved unanimously that the council reconfirm its support for the new speed limit.

519.5/25 Calstone A4 Junction

To authorise the Council's contribution of £930 towards the cost of a Speed Limit Review on the national speed limit section of the A4 between Cherhill and Quemerford.

Budget: Road Safety Budget (to be funded from CIL Reserve).

Power: Road Traffic Regulations Act 1984 S72

It was resolved unanimously to approve the contribution of £930 towards the cost of a speed limit review.

519.6/25 Stockley (and Heddington) Speed Limit Review - approval of increase to Parish Contribution

To authorise an increase in the Council's contribution towards the cost of a Speed Limit Review of the roads around Stockley, Broads Green and to the west of Heddington, from £870 to £930 (representing 30% of the current fee of £3,100).

Recommendation: that the Council approves an increased contribution of £930 towards the cost of a Speed Limit Review of the roads around Stockley, Broads Green and to the west of

Heddington.

Budget: Road Safety Budget (to be funded from CIL Reserve).

Power: Road Traffic Regulations Act 1984 S72

It was resolved unanimously to approve the increased contribution to £930.
